I am directed to refer to the provisions prescribed under Section 12C of the Homoeopathy Central Council Act, 1973 and regulations made thereunder. In order to verify the compliance of availability of standards by the College, the Board of Governors to CCH has conducted inspection of MNR Homoeopathic Medical College, 2-23B/350, Bhagyangar, Phase-III, Near HMT Hills Colony Opp. JNTU, Kukatpally, Hyderabad, Telengana, Pin-500072, on 19.03.2019 and furnished recommendation for allowing admission in 1-BHMS course for the session 2019-20 with intake capacity of 100 seats in existing UG(BHMS) course.

- 2. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC (MSR) Regulations, 2013, recommendations of the Board of Governors to CCH, permission of the Central Government is hereby granted to MNR Homoeopathic Medical College, 2-23B/350, Bhagyangar, Phase-III, Near HMT Hills Colony, Opp. JNTU, Kukatpally, Hyderabad, Telengana, Pin-500072 for continuing admissions in 1- BHMS course with intake capacity of 100 seats during the academic year 2019-20."
