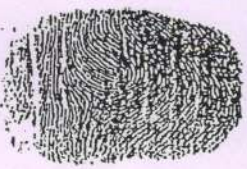





  - j) That the Quorum for any meeting of the Board of Trustees shall be TWO and one of the Trustees chosen on the occasion of the meeting shall preside over the meeting of the Board and all the Executive powers shall vest in the Managing Trustee;


